

## Annex No. 1 to certificate No. 100-064364

### Conditions for the validity and use of the certificate:

1. The certificate of conformance can only be used for the purpose for which it was issued.
2. The certified product must continue to conform with the technical specification.
3. The certificate holder is obliged to:
  - a) inform the certification body of all changes: modifications to the product or production process, changes in materials, changes in the production management system that have an influence on the conformity of the certified product;
